2011 Castaldi Award Criteria

Lawrence Castaldi led the Indiana Association of United Ways for its first three years and served on its board until his death in 1985. Upon his retirement as board chairman in 1980, the Association presented him with its first award, recognizing the invaluable contribution he made to the United Way/Fund movement in Indiana. They named the award in his honor as a lasting tribute to his undaunting spirit of voluntarism, the same spirit that the Association salutes today through the Castaldi Award.

A. Purpose

To provide continuity of the “Castaldi Tradition” by recognizing the exemplary contribution of a Hoosier to advancing the United Way movement. The contribution should reflect the personal, passionate, persevering spirit exhibited by its namesake.

B. Innovative Community Involvement

The nominee invests in innovative work that takes the United Way/Fund to new levels of success or community involvement. Describe a specific example.

C. An Individual with Statewide and/or Regional Impact

The nominee should be an individual rather than an organization. It should be based on a personal achievement and/or contribution. The individual could be a volunteer or a professional acting as a volunteer or providing exceptional professional leadership to statewide efforts or similar leadership involving more than one county. Your nominee must meet this criterion.

D. A Hoosier Focus

The recipient should be either a current resident whose actions benefit Indiana or a former Indiana native making a contribution which is not limited to Indiana.

E. United Way Focused

The award should focus on an individual’s contribution to the United Way/Fund movement, ***rather than*** philanthropy in general or other service to social concerns.
